

Admission Notice for Ph.D Programme


Applications are invited for admission / Registration in Ph.D programme beginning from 1st February 2016 on prescribed Ph.D Registration form available at the Sales Counter of Patna University from the candidate who fulfills the eligibility criteria laid down in the Uniform Ordinance and Regulations governing award of Ph.D Degree by the Universities of Bihar communicated vide letter no. BSU-05/2010-1455/GS (I) dated 06.11.2012 of the Governor's Secretariat, Bihar.

The prescribed forms duly filled in and complete in all respect along with the self attested copies of the academic records, recent pp size photograph pasted on the form and draft synopsis will be accepted in the Department of the subject concerned latest by 30th November 2015 during office hours. The application forms and other relevant documents should have spiral binding in the following order: - Ph.D. Registration form, front page of the synopsis, synopsis, academic records (10th pass out certificate having date of birth, PG cert., NET/PRT cert., caste cert., employer's no objection cert. if any, publication etc.).

The Departmental Council will recommend at least two names of the Supervisors to the candidates as per the provisions mentioned in clause 4 (ii) of the above mentioned Uniform Ordinance and Regulations. The Departmental Council shall conduct an interview of the candidate as per the provisions of the clause 2 (v) of the said Uniform Ordinance and Regulations. The Department concerned will send application forms of the selected candidates after following reservation rules of the State Government latest by 21st December 2015 to the office of the Dean of the Faculty concerned as per the vacant seats available on the date of recommendation. The Dean of the Faculty concerned after scrutiny of the application forms will forward the same with their specific recommendation to the office of the Deputy Registrar, P.U. latest by 4th January 2016 to enable the office to place the same before the Post Graduate Research Council likely to be held in the 2nd week of January 2016.

The application forms not properly filled in and not found complete in all respect will be rejected at the initial stage by the office of the Dean of the Faculties concerned. The admission / registration in the Ph.D course is subject to the conditions and provisions laid down in the above mentioned Ordinance and Regulations.


